New Business:

GM Administration

- Jessica Radon Grace Manor Administrator
 - We are moving towards mandatory immunization policy as per Ministry of Long-Term Care Directive from October 1, 2021 which requires all staff, students, volunteers, and support workers be either fully immunized OR provide valid exemption from a physician or nurse practitioner. We are happy to report only 4 Grace Manor staff remain unimmunized and will be placed on unpaid leave of absence effective November 15, 2021. We continue with enhanced measures including active screening, rapid antigen testing (2x/week for fully immunized, daily for partially – able to go to floor rather then wait for test, daily for unimmunized – required to wait for result prior to entering the resident home areas.
 - Last week the National Advisory Committee on Immunization (NACI) provided recommendations that high-risk health care workers now qualify for 3rd dose booster shots for COVID-19 vaccine. We are currently awaiting further directions from Peel Public Health.
 - Influenza season is upon us. We are happy to report all consenting residents have received their flu shots! We are currently running simultaneous flu shot clinics for our staff in the Rapid Antigen Clinic. We will continue to work hard to create a barrier of protection for our residents from COVID, Influenza, and other infectious diseases.
 - As you may have noticed, we have temporarily moved our Rapid Antigen Clinic from the Atrium into the Chapel. We have done so strategically to allow for our residents, and their families to begin enjoying the atrium space again for activities, and visits. We have scheduled days for each unit to enjoy programming in the Atrium please see the resident activity calendars on each resident home area for specific dates/times for Atrium Activities. The space can also be enjoyed during a visit with your loved one. We ask that everyone continue to practice public health recommendations including universal masking (for visitors, and residents as tolerated), social distancing, hand hygiene, and enhanced cleaning and disinfecting. The next phase of our reopening plan is addressing the family room on the first floor to make it available for residents and families to enjoy meals or just family time during the winter months. We appreciate everyone's patience as we progress to some sense of normalcy at Grace Manor.
 - Ministry of Long-Term Care inspector was in on October 7-15, 2021 to review outstanding Compliance Order issued in August 2021 related to Medication Administration. During the inspection, the order was found to be in compliance and has been cleared. This inspection report will be discussed in detail during our November Townhall Meeting.
 - Family Townhall Meeting scheduled for Tuesday November 16, 2021 from 1:30pm to 2:30pm.
