- **Care Plan Update:** Jody asked Lynn to speak to this as she wanted this added (she had conversation with GM FC member RE process). Jody was hoping administrator would be on to talk further and members could be updated. Jody did say she would reach out to Aleksandra FM's administrator for further follow up and if anyone has any further inquires to let her know and she will follow up in regards to process. She didn't want to assume it to be the same until we hear! We will add to home update for July's meeting (tentatively speaking).
- **RAPS Program/Environment Update-**Jody updated members on Music and Memory program. All rec staff had training May 16/17. Now we are looking at training devices and supplies and will roll out trial in July. Jody will update members on progress, challenges etc.! Very exciting-1st group to trial is 1st floors both manors as the core group is moderate to advanced dementia. 10 residents will be trialed with majority on 1st floors. Member shared that when she visits, rec staff don't need to come and ask her mother if she wants to join in especially when they are there for a visit. Jody will reiterate this to staff so that they aren't bothered during family time. Jody also gave an update of upcoming programs regarding new entertainment, Blue-the mini horse and our 2nd annual pop up concert in the park with Cameron Caton 'AKA' Elvis! And we will be having critter visits in August. Jody will update everyone with more details as we get closer! Jody also spoke to the environmental scan that was done by visiting consultants from psychogeriatric outreach, Alzheimer's Society who came onsite and did an environmental scan of both manors. The committee is sharing it at the next meeting and will action some short-term wins. Jody will keep members updated. The report was very informative and the committee will move forward with some of the suggestions to make improvements to support our culture change/emotional based centered care moving forward!
